CTEC'S PURPOSE: To undertake projects and make recommendations concerning the protection or use of natural resources, including water resources and air quality, located within or directly affecting Chatham Township.

The Chatham Township Environmental Commission's goal is to provide a responsible environmental viewpoint to Township committees and boards and to undertake projects with a strong educational component in order to inform officials and residents about constructive actions that can be taken to preserve the environment.

3. Approve Meeting Minutes of February 5, 2025

Motion to approve Meeting Minutes of February 5, 2025 Lisa motioned to approve the meeting minutes; Jim seconded. All in favor.

4. Green Team updates

Activities that CTEC manages are all part of the Green Team. Chatham Township was awarded Bronze in 2024. CTEC may resubmit in the Spring of 2025, off-cycle, to regain Silver Certification.

5. Review unsolicited printed materials ordinance and discuss

The Ordinance which addresses opting out of unsolicited printed materials that are delivered to resident's is awaiting approval of the Township Committee. It is on the agenda for March 25th. After adoption, any company who distributes unsolicited printed materials will receive a copy of the Ordinance. CTEC discussed placing an editorial and information on the Township website so residents know that opting out of receiving unsolicited printed material is an option for them.

6. Adopt-A-Drain

CTEC plans to continue to raise awareness of the Adopt-A-Drain program. No specific plans were made at this time.

7. Township NRI discussion

The NRI was last updated in 2013. CTEC is eager to work in tandem with the Planning Board who needs to include the NRI in the updated 2027 Master Plan. CTEC submitted an application for a Sustainable Jersey/PSE&G technical assistance grant on Feb 13th, 2025 with letters of support from Mike Neibert of the Planning Board, Rich Young of the Township DPW and from Mayor Mike Choi of the Township Committee. The requested amount for the grant was originally going to be for \$20,000 but the actual grant request was for \$10,000 which was deemed to be more attainable.

8. Tree Ordinance

CTEC began to revisit the tree ordinance. CTEC has set a deadline for July 2025 to get proposed updates to the Township Committee. Discussion points included: a Tree Bank; a town arborist; recommendations to residents about what type of trees to replant, the best time of year and the size of tree for the best chance of survival; the current lengthy application to remove trees; and, enforcement mechanism for those who remove trees without proper approval or who don't actually do the required replanting.

9. Earth Day/Month 2025

Discussion about Earth Day to be celebrated April 26th. In addition to a walk and learn program and a clean-up, CTEC will host a tree seedling giveaway with trees purchased with CTEC funds from the NJ Forest Service.

Motion to approve spending funds to purchase tree seedlings from NJ Forest Service for a tree giveway on April 26^{th} in celebration of Earth Day

Jessica motioned to approve spending funds to purchase tree seedlings; Jim seconded. All in favor.

11. New Ideas for 2025

Ideas included: 1) a possible ordinance regarding small engines mainly leaf blowers and other landscaping types of equipment. More information will be gathered for discussion. Existing ordinances will be reviewed; 2) a possible Clean-up Program more targeted to roadways rather than public parks and fields, possibly involving the Garden Club and police for safety; 3) being more proactive on invasives including writing letters to the legislature about the sale of invasive

Ornamental Barberry; 4) options for composting, guest Tom Evans described the Green Cone Digester.
