Mayor Ewald called the Regular Meeting of the Township Committee of the Township of Chatham to order at 6:32 P.M.

Answering present to the roll call were Committeeman McHugh, Committeewoman Rowland, Deputy Mayor Choi and Mayor Ewald.

Committeeman Lois arrived during Executive Session.

Executive Session

Hearing of Citizens

Mayor Ewald opened the Hearing of Citizens. Seeing no further public comment, Mayor Ewald closed the Hearing of Citizens.

Workshop Session

Mountainview Playground

Mr. Shehady said that there is a resolution on the Consent Agenda to award a contract to a co-op for playground equipment for the Mountainview Playground. He said that drawings provided by the vendor were forwarded of the Township Committee in August, and were also included in the agenda packet. Mr. Shehady commented on the budget and the grant agreement that is part of the funding for the project.

Committeeman Lois said that he would like for workshop materials to be made available publicly.

Committeewoman Rowland asked about the accessibility of the playground equipment. Mr. Shehady said that the equipment is ADA compliant, and he commented on the difference between equipment that is actually inclusive versus that which is ADA compliant. Committeewoman Rowland asked about using environmentally friendly mulch. Mr. Shehady commented on efforts to use something environmentally friendly that still meets the risk management standards set by the Joint Insurance Fund.

Mayor Ewald asked if there is any rush to approve this project. Mr. Shehady said that the quote is only valid through the end of the year, and the cost may increase. He also said that the Township has until the end of June to finish the project under the terms of the grant agreement.

Deputy Mayor Choi asked about getting an opinion from the Environmental Commission about the mulch material. Mr. Shehady said that can be done.

Mr. Shehady commented on the resolutions for cancellation of property taxes. Mr. LaConte commented on the Redemption of Outside Lien resolutions.

Regular Meeting Session

Mayor's Message

Mayor Ewald addressed recent drone sightings, and said that the Township is taking them seriously. Mayor Ewald said that she, the Township Administrator and the Police Chief have reached out to County, State and Federal officials regarding the drones. Any sightings should be reported to the FBI, and there is not currently any known threat.

As it is the last meeting of the year, Mayor Ewald extended thanks to Mr. Shehady and the Township Staff, as well as the Township Committee, for all their work this past year.

On December 12th, the Winter Wonderland event will be held at the Municipal Building from 6:30 to 8:30.

On December 18th there will be the ribbon cutting for Cornerstone Housing. Mayor Ewald commented on the shuttle service that will be provided to the Madison Train Station.

Mayor Ewald thanked Committeeman Lois for his service to the Township over the past three years, and she congratulated Committeeman-Elect Craig Alperowitz on his election.

Township Committee Reports

Committeeman Lois lamented that JCP&L was not invited to make a presentation to the Township Committee about their recent rate increases. He also commented on MACC funds that he would like to see used for a teen center. Committeeman Lois further recommended that

Colony Pool rates and membership outreach start earlier in the year. He recommended that the relationship with the Colony Pool Advisory Committee be repaired.

Committeeman McHugh reported that the Library's Holiday Book Sale was successful. He also reported on programs being held at the Library. Committeeman McHugh thanked the Library staff for their diligent work.

Committeewoman Rowland thanked everyone she has had the opportunity to work with during the past year during her work as a Township Committee member.

Deputy Mayor Choi gave commendation to Chairman Tom Claps and the members of the Joint Recreation Committee for their work this year to analyze the potential impact if participants from Harding were to be included in the Joint Recreation Program. Deputy Mayor Choi reiterated that the Winter Wonderland is coming up on December 12th.
