Mayor Choi led the Flag Salute.

Mayor's Message

Mayor Choi said that tonight's agenda demonstrates that the Township Committee is taking action to ensure that the Administration and various boards are properly staffed. He also noted that a Municipal Services Agreement for the new Affordable Housing is on tonight's agenda.

Reports

Committeeman McHugh reported that the Friends of the Library Book Sale starts on March 8th. Free income tax preparation is available at the Library starting on Wednesdays through April 9th, and the Library can be contacted for people to find out if they are eligible for the free assistance. The Library is looking to hire an office manager. Committeeman McHugh reported that the Environmental Commission has applied for a grant to fun an update to the Natural Resources Inventory. The next phase of the Shunpike Restoration Project will be kicking off soon. The Open Space Committee met recently, and the National Trails Day is coming soon in April. The Open Space Committee is also investigating the possibility of utilizing using rights-of-way.

Committeewoman Ewald reported that the Senior Center has been closed for renovations. The Senior Center will celebrate their 35th anniversary on June 6th, and they will be honoring longtime trustee Jim Connelly. The Shred Event will be on April 26th at Chatham Middle School. The Colony Pool Advisory Committee will be meeting soon, and they will be organizing events and seeking a replacement for the log roll. Early bird pricing is available through March. Committeewoman Ewald recognized the Chatham Emergency Squad, and said that they recently had their officer installation. The new Township building will be reopened shortly.

Deputy Mayor Rowland reported that the Red Brick Schoolhouse will be open this Sunday from 2:00 to 4:00. She said there are often new items on display.

Committeeman Alperowitz commented on the Chatham Emergency Squad call statistics. He said he would like to have the Squad President and Captain give a formal report, and he said that there are often three calls per day. Committeeman Alperowitz indicated that CPR Training is also available through the Emergency Squad, and he encouraged residents to volunteer. Committeeman Alperowitz noted that the Hall of Fame Award was presented to Steve Davenport, who has been a volunteer at the Emergency Squad for over 20 years. Committeeman Alperowitz further noted that the Fire Departments used the recent cold weather to do frozen lake training. He also said that the Recreation Committee meets tomorrow evening.

Mayor Choi recognized Benjamin Bernich and Daniel Cvetkovic for their Eagle Scout Awards in Troop 8. He also said that both the Boys and Girls Swim Teams at Chatham High School won the State Group B Championships. Chatham Girls Basketball made it to the Morris County Finals. Seven Chatham High School Seniors have been recognized as National Merit Scholarship Finalists.

ORDINANCE OF THE TOWNSHIP OF CHATHAM, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AWARDING THE LEASE FOR, AND AUTHORIZING THE TOWNSHIP TO ENTER INTO, THE CELL TOWER LEASE FOR THE WIRELESS COMMUNICATIONS FACILITY AT 405 SOUTHERN BOULEVARD

WHEREAS, the Mayor and the Township Committee of the Township of Chatham (the "Township") adopted Resolution 2024-131 on May 21, 2024, authorizing the Township to publicly seek bids for a new land lease (the "Lease") for a portion of the property owned by the Township known as Block 48.16, Lot 117.27 and commonly known as the Department of Public Works site located at 405 Southern Boulevard, which contains the wireless communications facility (the "Property"); and

WHEREAS, the Township received two (2) bids on January 3, 2025, including a total bid for annual base rent year one of Forty-Eight Thousand Dollars (\$48,000.00) from Crown Atlantic Company LLC; and a total bid for annual base rent year one of Sixty-Three Thousand Six Hundred Sixty-Three Dollars (\$63,663.00) from Gaelic Communications LLC ("Gaelic"); and

WHEREAS, the Township Attorney reviewed the bids received and recommends awarding the Lease for the Property to Gaelic as the highest responsive and responsible bidder in the total amount of Sixty-Three Thousand Six Hundred Sixty-Three Dollars (\$63,663.00) (the "Lease Amount").

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Lease for the Property is hereby awarded to Gaelic in the amount of Sixty-Three Thousand Six Hundred Sixty-Three Dollars (\$63,663.00) for the annual base rent year one, subject to the terms and conditions set forth in the bid specifications. The Mayor, Township Administrator, Township Clerk and all other necessary Township personnel, are hereby directed and authorized to enter into the Lease for the Property with Gaelic, and to in all other ways carry out and effectuate the purposes thereof.

Section 3. If any part(s) of this ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereof shall not affect the remaining parts of this ordinance.

Section 4. This ordinance shall take effect in accordance with applicable law.

Section 2. Overtime for eligible employees shall be at the rate of straight time for hours exceeding 35 per week and one-half times employee's regular rate of pay for hours exceeding 40 per week.

Section 3. Employees covered by a collective bargaining agreement shall be entitled to compensation as provided in their respective agreements.

Section 4. Salaries provided herein shall be effective January 1, 2025, for those employed with the Township.

Section 5. When required by law, the Township shall pay at least the minimum wage established for the State of New Jersey.

Section 6. This ordinance shall take effect upon publication as provided by the law.

Mr. Shehady explained that this ordinance sets the ranges for salaries, and the actual salaries for 2025 will be set by resolution at a later time. The hope is that the ranges will be sufficient through 2028. He noted that there was a typo in the introduced version of the ordinance, and asked that it be amended to have the maximum salary for Colony Pool assistant managers be \$60 per hour.

business; (ii) eliminate the Recreation Committee as a separate committee as that role is merged with the Administration/Personnel/Communications Committee; and (iii) eliminate the liaison to the Public Utilities as that role is satisfied by the Public Works/Sewer Utilities Committee.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Township Code Chapter 2, Administration, Section 2-1.12, Rules and Order of Business of Township Committee, subsection 2-1.12(d), Order of Business, is hereby amended as follows:

ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 2, ADMINISTRATION, SECTION 2-11, POLICE DEPARTMENT, SUBSECTION 2-11.8, QUALIFICATIONS FOR APPOINTMENT, OF THE TOWNSHIP CODE

WHEREAS, Chapter 2, Administration, Section 2-11, Police Department of the Revised General Ordinances of the Township (the "Township Code") establishes the Police Department and outlines the composition of the Police Department and appointment of such officers; and

WHEREAS, N.J.S.A. 42:17b-66 <u>et seq</u>. established the police licensing program for all New Jersey law enforcement officers and requires that all law enforcement officers hold a valid, active license issued by the Police Training Commission in order to be employed as a police officer in the State of New Jersey; and

WHEREAS, the Township Committee of the Township of Chatham (the "**Township**") desires to amend the Township Code Chapter 2, Administration, Section 2-11, Police Department, subsection 2-11.8, Qualifications for Appointment, to ensure compliance with the police licensing requirements.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Township Code Chapter 2, Administration, Section 2-11, Section 2-11, Police Department, subsection 2-11.8, Qualifications for Appointment, is hereby amended to read as follows:

§ 2-11.8 Qualifications for Appointment.

Each person appointed to the Police Department shall meet the qualifications and requirements established by N.J.S.A. 40A:14-22 et seq. and any other applicable laws of the State of New Jersey. Additionally, pursuant to the provisions of N.J.S.A. 52:17B-67.1, all current and future law enforcement officers employed by the Township of Chatham Police Department shall hold a valid, active license issued by the Police Training Commission in order to be employed as a police officer in the State of New Jersey.

Section 3. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance and the

remainder of the Ordinance shall be deemed valid and effective, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. All ordinances or parts of ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This Ordinance shall take effect according to law.

ORDINANCE AMENDING CHAPTER 4, GENERAL LICENSING, OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING SECTION 4-2, PRIVATE ALARM SYSTEMS, OF THE TOWNSHIP CODE

WHEREAS, the Township Committee of the Township of Chatham (the "**Township**") adopted Ordinance 16-77 authorizing the implementation of the Private Alarm System Ordinance of the Township, which is codified in Section 4-2 of the Township Code; and

WHEREAS, as a result of the technological advances in private alarm systems, the Private Alarm System Ordinance has become redundant, an administrative burden, and incompatible with modern alarm monitoring practices; and

WHEREAS, the Township desires to amend the Township Code, Chapter 4, General Licensing, Section 4-2, Private Alarm Systems, to eliminate (i) the definitions of Private Alarm System and Warning Device from Subsection 4-2.2, Definitions; and (ii) subsection 4-2.3, Private Alarm System Requirements, subsection 4-2.4, Warning Devices, and subsection 4-2.5, Disclaimer of Responsibility, in their entirety.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Township Code Chapter 4, General Licensing, Section 4.2, Private Alarm Systems, subsection 4-2.2, Definitions, is hereby amended as follows:

§ 4-2.2 Definitions.

As used in this section:

FALSE ALARM

Shall mean:

- a. Any signal or message received at the police desk to which a response is initiated and which signal or message was directly or indirectly caused or produced by a private alarm system in the absence of any criminal activity or other emergency.
- b. Any sound by a warning device to which a response by the Chatham Township Police Department is initiated which was directly or indirectly caused or produced by a warning device in the absence of any criminal activity or other emergency.

Section 3. Township Code Chapter 4, General Licensing, Section 4-2, Private Alarm Systems, subsection 4-2.3, Private Alarm System Requirements, subsection 4-2.4, Warning Devices, and

subsection 4-2.5 Disclaimer of Responsibility, are hereby repealed and rescinded in their entirety, and shall no longer be of, or remain in, any force or effect.

Section 4. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, division, clause or provisions so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

Section 5. All Ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 6. This Ordinance shall take effect according to law.

WHEREAS, unsolicited materials can become the cause of rubbish strewn upon the streets and sidewalks of the Township of Chatham (the "Township") resulting in not only a poor appearance but also in clogging stormwater inlets, and placing persons and property in danger of flooding; and

WHEREAS, the Township Committee of the Township desires to amend the Revised General Ordinances of the Township (the "Township Code"), Chapter 4, General Licensing, Section 4-1, Licensing of Peddlers, Solicitors and Canvassers, subsection 4-1.24, Litter, to prevent unsolicited distribution of print materials which cause the aforementioned dangers; and

WHEREAS, the Township Committee believes it is in the best interests of the residents of the Township to adopt this Ordinance preventing the distribution of unsolicited print materials.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Township Code Chapter 4, General Licensing, Section 4-1, Licensing of Peddlers, Solicitors and Canvassers, subsection 4-1.24, Litter, is hereby amended to read as follows:

§ 4-1.24. Litter.

a. No peddler, solicitor or canvasser shall cause any litter or distribute any printed material to houses in the Township by throwing or dropping such material on driveways, walks or lawns or distribute any printed material in a manner that is likely to cause it to become windblown.

b. It shall be unlawful for any person to deliver or deposit, or for any person, firm or corporation to cause the delivery or deposit of, any unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material to or upon any private premises within the Township, except in accordance with the terms hereof. For the purposes of this section, "unsolicited" shall mean unsolicited advertising circulars, newspapers and other like-printed material which has not been ordered, subscribed to or requested by the recipient.

c. Such unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material shall be placed at the primary entrance of the premises, on the ground or floor at the place where the premises receives its mail or within a three-foot radius of that point. The unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material shall clearly state

the contact person and telephone number to whom notice may be given, requesting that such delivery of the unsolicited advertising circulars, newspapers and other like-printed material be ceased or canceled.

d. There shall be no intentional delivery of any such unsolicited printed material to the premises after the owner or tenant of such premises has notified the contact person, referred to in subsection C hereof, that such delivery shall cease or be suspended for a stated period of time. For the purposes of condominiums or other common properties, notification must come from the individual unit owner or tenant.

e. Any person found to be in violation of the provisions of this Section 4-1.24 shall be subject to a fine as follows:

- 1. First offense: \$100.
- 2. Second offense: \$200.
- 3. Any subsequent offense: \$300.

Each day a violation continues shall be deemed a separate offense.

Section 3. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance and the remainder of the Ordinance shall be deemed valid and effective, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. All ordinances or parts of ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This Ordinance shall take effect according to law.

Mr. Shehady said that this ordinance is being considered at the request of the Environmental Commission. He said that the public will be given the opportunity to opt out of receiving unsolicited printed material.

Committeeman McHugh moved to introduce Ordinance 2025-07. Committeeman Alperowitz seconded the motion.

Committeeman McHugh commented that this ordinance has input form the Environmental Commission, the Township Administration and from the public. He also said that all opinions were considered, and it is an example of government working effectively.

CTEC Chairwoman Jessica Romeo said that the Environmental Commission will review the ordinance next week.

Mayor Choi noted that Ordinance 2025-07 is a quality of life ordinance.

ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Chatham in the County of Morris finds it advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$136,192.95 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Chatham, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Township of Chatham shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$476,675.33, and that the CY 2025 municipal budget for the Township of Chatham be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mr. Shehady said that the Cap Bank Ordinance is a normal tool in the budget process, and it allows municipalities to increase the cap to 3.5% and bank any unused portion to potentially be used in future years in the event of an emergency. Mr. Shehady also clarified that the ordinance does not allow municipalities to increase taxes. He further noted that the 2025 budget is still being drafted.

Committeeman McHugh moved to introduce Ordinance 2025-08. Committeewoman Ewald seconded the motion.
