MINUTES TOWNSHIP COMMITTEE REGULAR MEETING MARCH 25, 2025

Mayor Choi called the Regular Meeting of the Township Committee of the Township of Chatham to order at 7:30 P.M.

Adequate Notice of this meeting of the Township Committee was given as required by the Open Public Meetings Act as follows: Notice was given to both *The Chatham Courier* and the *Morris County Daily Record* on January 8, 2025; notice was posted on the bulletin board in the main hallway of the Municipal Building on January 8, 2025; and notice was filed with the Township Clerk on January 8, 2025.

Roll Call

Answering present to the roll call were Committeeman Alperowitz, Committeewoman Ewald, Committeeman McHugh, Deputy Mayor Rowland and Mayor Choi.

Committeeman McHugh participated via Zoom.

Mayor Choi led the Flag Salute.

Mayor's Message

Mayor Choi announced that online payments will soon be available for the Construction Department and for pet licensing. He also commented on the proposed 2025 Budget, and highlighted appropriations and use of fund balances. Mayor Choi also said that for a house with an average assessment, the municipal purposes portion of a property tax bill would be \$2969, up from \$2797.

Mayor Choi noted that orders for mulch deliveries are now being accepted by the Department for Public Works.

Reports

Committeeman McHugh reported that the Community Garden Committee will have a meeting on March 27th, and they will have a guest speaker. The fence along the north side of the Community Garden is going to be replaced. The Friends of the Library Book Sale raised almost \$45,000 this year. The Library has a Museum Passes program. Committeeman McHugh noted that the Library is having a program on jewelry appraisals on April 13th. He also reported that Earth Day is in April, and the Environmental Commission is holding a native plants sale and a seedling giveaway. Work will also be done at the Shunpike Reforestation Project. The Open Space Committee will be highlighting National Trails Day. A program will be held by the Environmental Commission about invasive species.

Committeewoman Ewald reported that upgrades to Colony Pool are being considered, and plans will be posted on the Township website. The appointment of a new Pool Manager and two assistant managers is on the Consent Agenda. Committeewoman Ewald reported that the Events Committee is planning a spring event. She further reported that the Senior Center has reopened following building improvements, and they are planning an event in June. The Shred Event will be on April 26th. The Planning Board met recently and discussed detached accessory units. Committeewoman Ewald thanked Carol Nauta for her service as Recreation Director, and wished her the best in her retirement.

Deputy Mayor Rowland reported that the Board of Education presented their budget. She also reported that the calendar has been updated to use three unused snow days. Deputy Mayor Rowland reported on the recent Historical Society meeting.

Committeeman Alperowitz reported that basketball season is wrapping up, and spring youth sports are starting up. Adult basketball and women's volleyball both have openings. He also thanked Carol Nauta for her work in the Chatham Recreation Program. Committeeman

Alperowitz recognized the efforts of the Public Works Department to prepare recreation fields for use.

Mayor Choi recognized Carol Nauta upon her retirement. He also recognized the appointment of Phil Ankel and Elin Khroun to the Garden Committee, and Steve Gesell to the Environmental Commission.

Hearing of Citizens

Mayor Choi opened the Hearing of Citizens. Seeing no public comment, Mayor Choi closed the Hearing of Citizens.

Committeewoman Ewald noted that several decades ago a dinosaur footprint was found at Esternay Field.

ORDINANCE 2025-07

ORDINANCE OF TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 4, GENERAL LICENSING, SECTION 4-1, LICENSING OF PEDDLERS, SOLICITORS AND CANVASSERS, SUBSECTION 4-1.24, LITTER, OF THE TOWNSHIP CODE

WHEREAS, unsolicited materials can become the cause of rubbish strewn upon the streets and sidewalks of the Township of Chatham (the "Township") resulting in not only a poor appearance but also in clogging stormwater inlets, and placing persons and property in danger of flooding; and

WHEREAS, the Township Committee of the Township desires to amend the Revised General Ordinances of the Township (the "Township Code"), Chapter 4, General Licensing, Section 4-1, Licensing of Peddlers, Solicitors and Canvassers, subsection 4-1.24, Litter, to prevent unsolicited distribution of print materials which cause the aforementioned dangers; and

WHEREAS, the Township Committee believes it is in the best interests of the residents of the Township to adopt this Ordinance preventing the distribution of unsolicited print materials.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Township Code Chapter 4, General Licensing, Section 4-1, Licensing of Peddlers, Solicitors and Canvassers, subsection 4-1.24, Litter, is hereby amended to read as follows:

§ 4-1.24. Litter.

- a. No peddler, solicitor or canvasser shall cause any litter or distribute any printed material to houses in the Township by throwing or dropping such material on driveways, walks or lawns or distribute any printed material in a manner that is likely to cause it to become windblown.
- b. It shall be unlawful for any person to deliver or deposit, or for any person, firm or corporation to cause the delivery or deposit of, any unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material to or upon any private premises within the Township, except in accordance with the terms hereof. For the purposes of this section, "unsolicited" shall mean unsolicited advertising circulars, newspapers and other like-printed material which has not been ordered, subscribed to or requested by the recipient.
- c. Such unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material shall be placed at the primary entrance of the premises, on the ground or floor at the place where the premises receives its mail or within a three-foot radius of that point. The unsolicited for profit or commercial advertising circulars, newspapers and other like-printed material shall clearly state the contact person and telephone number to whom notice may be given, requesting that such delivery of the unsolicited advertising circulars, newspapers and other like-printed material be ceased or canceled.
- d. There shall be no intentional delivery of any such unsolicited printed material to the premises after the owner or tenant of such premises has notified the contact person, referred to in subsection C hereof, that such delivery shall cease or be suspended for a stated period of time. For the purposes of condominiums or other common properties, notification must come from the individual unit owner or tenant.

- e. Any person found to be in violation of the provisions of this Section 4-1.24 shall be subject to a fine as follows:
 - 1. First offense: \$100.
 - 2. Second offense: \$200.
 - 3. Any subsequent offense: \$300.

Each day a violation continues shall be deemed a separate offense.

- **Section 3.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance and the remainder of the Ordinance shall be deemed valid and effective, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- **Section 4.** All ordinances or parts of ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
 - **Section 5.** This Ordinance shall take effect according to law.

Committeeman Alperowitz moved to adopt Ordinance 2025-07. Deputy Mayor Rowland seconded the motion.

ORDINANCE 2025-08

ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Chatham in the County of Morris finds it advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$136,192.95 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Chatham, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Township of Chatham shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$476,675.33, and that the CY 2025 municipal budget for the Township of Chatham be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mr. Shehady explained how the Cap Bank works.

ORDINANCE 2025-09

ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 30, LAND DEVELOPMENT, SECTION 30-17, FEES, OF THE TOWNSHIP CODE TO UPDATE CERTAIN LAND USE APPLICATION FEES

WHEREAS, the Township Committee of the Township of Chatham (the "**Township**") desires to amend Chapter 30, Land Development, Section 30-17, Fees, of the Township Code to update certain land use application fees; and

WHEREAS, upon first reading of this ordinance, the Township refers this ordinance to the Township Planning Board pursuant to N.J.S.A. 40:55D-26, requesting that they review it for consistency with the Township's Master Plan and to prepare recommendations regarding the amendments contained herein; and

WHEREAS, upon first reading of this ordinance, the Township directs the Township Clerk and Township Attorney to provide the required public notice of the public hearing for second reading and adoption as set forth in N.J.S.A. 40:55D-15.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

- **Section 1.** The aforementioned recitals are incorporated herein as though fully set forth at length.
- **Section 2**. The Township Code, Chapter 30, Land Development, Section 30-17, Fees, subsection 30-17.1, Fees, paragraph a, Application Fees, is hereby amended as follows:
 - a. Application Fees. At the time of an application for development the applicant shall pay to the Township application fees in accordance with the following schedule:
 - 1. Concept Plan: \$500.
 - 2. Minor Subdivision Simple Lot Line Change: \$250.
 - 3. Minor Subdivision Three lots or less: \$475.
 - 4. Preliminary Plat Major Subdivision: \$300 plus \$150 per lot
 - 5. Final Plat Major Subdivision: \$300 plus \$100 per lot.
 - 6. Preliminary Site Plan Conventional: \$300 plus \$50 for each 1,000 square feet or fraction thereof.
 - 7. Final Site Plan Conventional: One-half of fee for Preliminary Site Plan.
 - 8. Preliminary Site Plan Multi-Family: \$300 plus \$50 per 1,000 square feet of floor area or fraction thereof.
 - 9. Final Site Plan Multi-Family: One-half of fee for Preliminary Site Plan.
 - 10. Master Development Plan Multi-Family Housing Development: \$1,500 plus \$50 per dwelling unit.

- 11. Waiver of Complete Site Plan Approval: \$400.
- 12. Amended Site Plan: \$400.

Section 3. The Township Code, Chapter 30, Land Development, Section 30-17, Fees, subsection 30-17.2, Conditional Uses, Variances and Appeals, is hereby amended as follows:

f.	Direction pursuant to Subsection 30-47.6 for issuance of a permit for building or structure in the bed of a mapped street or public drainageway, flood control basin or public area reserved on an official map.	\$200
g.	Direction pursuant to Subsection 30-47.7 for issuance of a permit for a building or structure not related to a street.	\$200
h.	The fees in Subsections a through g inclusive above shall be in addition to any applicable fee in connection with a subdivision or site plan as provided in Subsection 30-17.1.	
i.	Appeals to the Township Committee pursuant to 30-13.	\$300

Section 4. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance and the remainder of the Ordinance shall be deemed valid and effective, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 5. All ordinances or parts of ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 6. Pursuant to N.J.S.A. 40:55D-16, upon adoption, the Township Clerk shall file a copy of this ordinance with the County Planning Board. Thereafter, this Ordinance shall take effect according to law.

Mr. Shehady said that this ordinance addresses costs for land use board applications. The fees are proposed to be raised due to rising costs and so that tax payers do not have to subsidize costs that should be borne by those submitting applications to the Planning Board or the Zoning Board.

Committeeman Alperowitz moved to introduce Ordinance 2025-09. Committeewoman Ewald seconded the motion.

Committeeman Alperowitz said that these increases are overdue, and noted that there is not any burden on taxpayers.

ORDINANCE OF THE TOWNSHIP OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE TOWNSHIP TO ENTER INTO A PURCHASE AND SALE AGREEMENT, PROVIDING FOR THE SALE OF PROPERTY LOCATED IN THE TOWNSHIP OF CHATHAM AND IDENTIFIED IN THE TOWNSHIP TAX RECORDS AS BLOCK 62, LOT 71.01, PURSUANT TO THE LOCAL LANDS AND BUILDINGS LAW

WHEREAS, the Township of Chatham (the "Township") is a public body corporate and politic of the State of New Jersey, and, pursuant to N.J.S.A. 40A:12-13(b)(5) of the New Jersey Local Lands and Buildings Law, N.J.S.A. 40A:12-1 *et seq*. (the "LLBL"), the Township has determined to sell the real property located in the Township of Chatham, State of New Jersey designated as Block 62, Lot 71.01 (the "Property") and to exercise the powers contained in the LLBL to facilitate such sale; and

WHEREAS, Deniz Sinal (the "**Buyer**") is the owner of certain real property designated as Block 62, Lot 72, commonly known as 476 River Road, which is contiguous with the Property that is being sold to Buyer in order to eliminate an existing encroachment by Buyer; and

WHEREAS, on December 6, 2023, the Township commissioned an appraisal of the Property from David Mailman, ASA, IFAS, SCGREA, Certified General Real Estate Appraiser, to determine the fair market value of the Property (the "**Appraisal Report**"), a copy of which is on file with the Township Clerk; and

WHEREAS, the Appraisal Report determined the fair market value of the Property to be Twenty Thousand Dollars (\$20,000); and

WHEREAS, the Township wishes to sell the Property to the Buyer at private sale pursuant to the authority granted to it under the LLBL; and

WHEREAS, pursuant to N.J.S.A. 40A:12-13(b)(5) of the LLBL, the Township may sell real property at private sale; and

WHEREAS, in furtherance of the transactions contemplated herein, the Township and Buyer entered into a certain Escrow Agreement, pursuant to which the Buyer deposited the Purchase Price (as defined herein) for the purchase of the Property with the Township; and

WHEREAS, the Township desires to sell the Property to Buyer for a price of Twenty Thousand Dollars (\$20,000.00) (the "**Purchase Price**"), pursuant to the terms of a purchase and sale agreement, substantially in the form attached hereto as **Exhibit A** (the "**PSA**"), negotiated between the Township and Buyer.

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Chatham, County of Morris, and the State of New Jersey, as follows:

Section 1. The aforementioned recitals are hereby incorporated by reference as if fully set forth herein.

- **Section 2.** The Township Committee approves the PSA in substantially the form attached hereto as **Exhibit A**, together with any changes, insertions and omissions, after the Mayor's consultation with counsel to the Township, deemed in their collective discretion to be necessary or desirable for the execution thereof.
- **Section 3**. The Mayor and other necessary and desirable Township officials/employees and Township consultants are authorized to execute, deliver and administer the PSA, and take any other necessary actions or refrain from taking actions, execute and deliver documents and/or agreements that are reasonable and necessary to effectuate the PSA, this Ordinance and to close on the sale of the Property.
- **Section 4.** The Township Committee further authorizes the sale of, and closing on the purchase of the Property to the Buyer in accordance with the PSA and the Mayor and other necessary and desirable Township officials/employees are hereby authorized to convey the Deed to the Property and any and all associated documents by and between the Buyer and the Township, and any other documents in accordance with the PSA and this Ordinance as reasonably required to effectuate said sale.
- **Section 5**. The Township Clerk shall post this Ordinance on the bulletin board or other conspicuous space in the Municipal Building where the Township Committee holds its regular meetings, and shall further advertise this Ordinance, and the sale of the Property contemplated herein, in a newspaper circulating in the Township of Chatham within five (5) days of adoption of this Ordinance.
- **Section 6**. The Township Clerk shall file sworn affidavits verifying the publication of advertisement of the Ordinance, and the sale of the Property contemplated herein, with the Director of the Division of Local Government Services in the Department of Community Affairs.
- **Section 7**. If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.
- **Section 8.** This Ordinance shall take effect upon final passage and publication according to law.

Mr. Shehady explained that this ordinance is for a land sale regarding an encroachment onto municipal property.

Deputy Mayor Rowland moved to introduce Ordinance 2025-10. Committeewoman Ewald seconded the motion.

WHEREAS, CJ Griffin, Esq. of Pashman, Stein, Walder, Hayden, on behalf of Antonio Fuster and Brianna Devine, had filed certain litigation against the Township of Chatham and the Township Clerk (for ease of reference collectively the "Township"), with respect to their request under the Open Public Records Act ("OPRA") for certain government records, and specifically, to obtain certain body worn camera footage from the Township Police Department (the "BWC footage"), which litigation was initially brought before the Superior Court and captioned *Antonio Fuster and Brianne Devine*, *v. Chatham Township*, *et al.*, Docket No. MRS-L-1814-22, and then proceeded through the Appellate Division (Docket No. A-1673-22) and into the New Jersey Supreme Court (Docket No. 089030 (collectively, the "Litigation"); and

WHEREAS, following argument before the New Jersey Supreme Court in the Litigation, the Court, in *Antonio Fuster and Brianne Devine v. Chatham Township, et al.*, 259 N.J. 533 (2025), issued a published opinion which determined that the BWC footage be disclosed to Fuster and Devine, a determination which, under pre-September 3, 2024 amendments to OPRA (which apply to this case, which was commenced *prior to* those amendments), directs that a fee award be made in favor of Fuster and Devine, since they are prevailing party in the Litigation which resulted in the production of the sought BWC footage; and

WHEREAS, in the wake of the above ruling by the New Jersey Supreme Court in the Litigation, the parties were able to reach an amicable resolution of the fee award issue without further litigating the same, agreeing upon the payment of attorney's fees and costs in the amount of \$140,000.00, a nearly fifteen percent reduction from the \$164,000 originally sought by counsel; and

WHEREAS, the Township, in consideration of the forgoing and the attendant cost and expense of continuing the Litigation given the entitlement to a fee award, particularly given the fee shifting provisions under the pre-amendment provisions of OPRA which apply to this case, is desirous of authorizing the settlement and compromise of the same, including the authorization of the payment of \$140,000.00 for attorney's fees and costs, all as aforesaid.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:
