### **RESOLUTION 2025-P-09**

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING CONFERENCE OF THE TOWNSHIP COMMITTEE WITH THE PUBLIC EXCLUDED

## Mayor's Message

Mayor Choi thanked Mr. Shehady, Mrs. Cofoni and Mr. Young for their work on preparations for the 2025 Colony Pool season. He also thanked Mr. Ruschke for his work on procuring various grants, and thanked Chief Miller for his efforts to improve the efficiency and effectiveness of the Township Police Department. Mayor Choi further thanked Mr. Shehady,

Mrs. King, Mr. Daniels and Mr. LaConte for he work they due that resulted in the Township's 2024 Audit resulting in positive results.

Mayor Choi noted that the Township will be working on the redesign of Colony Pool, the future of the Fenske property and the Fourth Round of affordable housing.

Mayor Choi noted the teamwork that goes into addressing the variety of issues that face the Township.

### **Reports**

Deputy Mayor Roland reported that the next open house at the Red Brick Schoolhouse will be on May 2<sup>nd</sup>.

Committeeman McHugh reported that the Library consortium migrated to a new system, which means that users need to update their passwords. He further reported that the Library is offering a series of STEAM programs for children ages 1 to 14. Committeeman McHugh stated that there will be tree plantings, tree giveaways and an environmental cleanup at Shunpike Field on April 26<sup>th</sup>.

Committeewoamn Ewald noted that through the Library, there are several websites accessible such as Ancestry.com that normally require paid access. The Senior Center will host their Shred Event fundraiser on April 26<sup>th</sup>. On June 6<sup>th</sup> the Senior Center will host a 35<sup>th</sup> Anniversary fundraiser event that will also honor trustees board president Jim Connolly. There was recently a ribbon cutting at the Senior Center following the facilities upgrades. Committeewoman Ewald noted the variety of programs hosted by the Senior Center. Committeewoman Ewald further reported on the events planned at Colony Pool during the 2025 season. The Planning Board is discussing the Housing Element and Fair Share Plan updates for the Fourth Round, and there is also an application for a subdivision near the intersection of Maple and Cedar. On April 26<sup>th</sup>, the Events Committee will host their Spring Fling.

Ordinance 2025-09

### **ORDINANCE 2025-09**

ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 30, LAND DEVELOPMENT, SECTION 30-17, FEES, OF THE TOWNSHIP CODE TO UPDATE CERTAIN LAND USE APPLICATION FEES

**WHEREAS**, the Township Committee of the Township of Chatham (the "**Township**") desires to amend Chapter 30, Land Development, Section 30-17, Fees, of the Township Code to update certain land use application fees; and

**WHEREAS**, upon first reading of this ordinance, the Township refers this ordinance to the Township Planning Board pursuant to N.J.S.A. 40:55D-26, requesting that they review it for consistency with the Township's Master Plan and to prepare recommendations regarding the amendments contained herein; and

**WHEREAS**, upon first reading of this ordinance, the Township directs the Township Clerk and Township Attorney to provide the required public notice of the public hearing for second reading and adoption as set forth in N.J.S.A. 40:55D-15.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

- **Section 1.** The aforementioned recitals are incorporated herein as though fully set forth at length.
- **Section 2**. The Township Code, Chapter 30, Land Development, Section 30-17, Fees, subsection 30-17.1, Fees, paragraph a, Application Fees, is hereby amended as follows:

- a. Application Fees. At the time of an application for development the applicant shall pay to the Township application fees in accordance with the following schedule:
  - 1. Concept Plan: \$500.
  - 2. Minor Subdivision Simple Lot Line Change: \$250.
  - 3. Minor Subdivision Three lots or less: \$475.
  - 4. Preliminary Plat Major Subdivision: \$300 plus \$150 per lot
  - 5. Final Plat Major Subdivision: \$300 plus \$100 per lot.
  - 6. Preliminary Site Plan Conventional: \$300 plus \$50 for each 1,000 square feet or fraction thereof.
  - 7. Final Site Plan Conventional: One-half of fee for Preliminary Site Plan.
  - 8. Preliminary Site Plan Multi-Family: \$300 plus \$50 per 1,000 square feet of floor area or fraction thereof.
  - 9. Final Site Plan Multi-Family: One-half of fee for Preliminary Site Plan.
  - 10. Master Development Plan Multi-Family Housing Development: \$1,500 plus \$50 per dwelling unit.
  - 11. Waiver of Complete Site Plan Approval: \$400.
  - 12. Amended Site Plan: \$400.

Section 3. The Township Code, Chapter 30, Land Development, Section 30-17, Fees, subsection 30-17.2, Conditional Uses, Variances and Appeals, is hereby amended as follows:

f.	Direction pursuant to Subsection 30-47.6 for issuance of a permit for building or structure in the bed of a mapped street or public drainageway, flood control basin or public area reserved on an official map.	\$200
g.	Direction pursuant to Subsection 30-47.7 for issuance of a permit for a building or structure not related to a street.	\$200
h.	The fees in Subsections a through g inclusive above shall be in addition to any applicable fee in connection with a subdivision or site plan as provided in Subsection 30-17.1.	
i.	Appeals to the Township Committee pursuant to 30-13.	\$300

- **Section 4.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance and the remainder of the Ordinance shall be deemed valid and effective, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- **Section 5.** All ordinances or parts of ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
- **Section 6.** Pursuant to N.J.S.A. 40:55D-16, upon adoption, the Township Clerk shall file a copy of this ordinance with the County Planning Board. Thereafter, this Ordinance shall take effect according to law.

Mr. Shehady provided an overview of Ordinance 2025-09, and indicated that the fees are being raised so that application costs are not subsidized by tax payers. He also stated that the Planning Board conducted a Master Plan Consistency Review, and determined that Ordinance 2025-09 is not inconsistent with the Master Plan.

Mayor Choi opened the Public Hearing on Ordinance 2025-09. Seeing none, Mayor Choi closed the Public Hearing.

Committeewoman Ewald moved to adopt Ordinance 2025-09. Committeeman McHugh seconded the motion.

Committeewoman Ewald noted that the fees involved are use fees. She said that the fees in neighboring towns were surveyed, and she is satisfied with the draft ordinance.

Mayor Choi noted that the ordinance adds a fee for amended site plans.

### **ORDINANCE 2025-10**

ORDINANCE OF THE TOWNSHIP OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE TOWNSHIP TO ENTER INTO A PURCHASE AND SALE AGREEMENT, PROVIDING FOR THE SALE OF PROPERTY LOCATED IN THE TOWNSHIP OF CHATHAM AND IDENTIFIED IN THE TOWNSHIP TAX RECORDS AS BLOCK 62, LOT 71.01, PURSUANT TO THE LOCAL LANDS AND BUILDINGS LAW

**WHEREAS**, the Township of Chatham (the "**Township**") is a public body corporate and politic of the State of New Jersey, and, pursuant to N.J.S.A. 40A:12-13(b)(5) of the New Jersey Local Lands and Buildings Law, N.J.S.A. 40A:12-1 *et seq*. (the "**LLBL**"), the Township has determined to sell the real property located in the Township of Chatham, State of New Jersey designated as Block 62, Lot 71.01 (the "**Property**") and to exercise the powers contained in the LLBL to facilitate such sale; and

**WHEREAS**, Deniz Sinal (the "**Buyer**") is the owner of certain real property designated as Block 62, Lot 72, commonly known as 476 River Road, which is contiguous with the Property that is being sold to Buyer in order to eliminate an existing encroachment by Buyer; and

**WHEREAS**, on December 6, 2023, the Township commissioned an appraisal of the Property from David Mailman, ASA, IFAS, SCGREA, Certified General Real Estate Appraiser, to determine the fair market value of the Property (the "**Appraisal Report**"), a copy of which is on file with the Township Clerk; and

**WHEREAS**, the Appraisal Report determined the fair market value of the Property to be Twenty Thousand Dollars (\$20,000); and

**WHEREAS**, the Township wishes to sell the Property to the Buyer at private sale pursuant to the authority granted to it under the LLBL; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12-13(b)(5) of the LLBL, the Township may sell real property at private sale; and

**WHEREAS**, in furtherance of the transactions contemplated herein, the Township and Buyer entered into a certain Escrow Agreement, pursuant to which the Buyer deposited the Purchase Price (as defined herein) for the purchase of the Property with the Township; and

**WHEREAS**, the Township desires to sell the Property to Buyer for a price of Twenty Thousand Dollars (\$20,000.00) (the "**Purchase Price**"), pursuant to the terms of a purchase and sale agreement, substantially in the form attached hereto as **Exhibit A** (the "**PSA**"), negotiated between the Township and Buyer.

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Chatham, County of Morris, and the State of New Jersey, as follows:

**Section 1.** The aforementioned recitals are hereby incorporated by reference as if fully set forth herein.

- **Section 2.** The Township Committee approves the PSA in substantially the form attached hereto as **Exhibit A**, together with any changes, insertions and omissions, after the Mayor's consultation with counsel to the Township, deemed in their collective discretion to be necessary or desirable for the execution thereof.
- **Section 3**. The Mayor and other necessary and desirable Township officials/employees and Township consultants are authorized to execute, deliver and administer the PSA, and take any other necessary actions or refrain from taking actions, execute and deliver documents and/or agreements that

are reasonable and necessary to effectuate the PSA, this Ordinance and to close on the sale of the Property.

- **Section 4**. The Township Committee further authorizes the sale of, and closing on the purchase of the Property to the Buyer in accordance with the PSA and the Mayor and other necessary and desirable Township officials/employees are hereby authorized to convey the Deed to the Property and any and all associated documents by and between the Buyer and the Township, and any other documents in accordance with the PSA and this Ordinance as reasonably required to effectuate said sale.
- **Section 5**. The Township Clerk shall post this Ordinance on the bulletin board or other conspicuous space in the Municipal Building where the Township Committee holds its regular meetings, and shall further advertise this Ordinance, and the sale of the Property contemplated herein, in a newspaper circulating in the Township of Chatham within five (5) days of adoption of this Ordinance.
- **Section 6**. The Township Clerk shall file sworn affidavits verifying the publication of advertisement of the Ordinance, and the sale of the Property contemplated herein, with the Director of the Division of Local Government Services in the Department of Community Affairs.
- **Section 7**. If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.
- **Section 8.** This Ordinance shall take effect upon final passage and publication according to law.

Mr. Shehady said an ordinance is needed when a municipality wants to sell land. He provided an overview of the encroachment that this ordinance will correct through a land sale.

Mayor Choi opened the Public Hearing on Ordinance 2025-10. Seeing none, Mayor Choi closed the Public Hearing.

Mayor Choi noted that the encroachment in question could have impeded an affordable housing objective. He thanked Mr. Shehady, Mrs. Cofoni and Mr. Ruschke for their efforts in effectuating the land sale.

Committeeman McHugh moved to adopt Ordinance 2025-10. Committeewoman Ewald seconded the motion.

## **ORDINANCE 2025-11**

ORDINANCE AMENDING CHAPTER 2, ADMINISTRATION, ARTICLE III. DEPARTMENTS ESTABLISHED, SECTION 2-11, POLICE DEPARTMENT, SUBSECTION 2-11.7, POLICE DEPARTMENT PERSONNEL OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY

**WHEREAS**, the Township Committee of the Township of Chatham (the "**Township**") desires to amend Chapter 2, Administration, Article III, Departments Established, Section 2-11, Police Department, subsection 2-11.7, Police Department Personnel, of the Revised General Ordinances of the Township of Chatham, to update the organization and personnel of the Township Police Department to increase the number of Sergeants by one and to reduce the number of patrol officers by one, maintaining the same total number of police personnel.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

**Section 1**. The aforementioned recitals are incorporated herein as though fully set forth at length.

**Section 2**. Chapter 2, Administration, Article III, Departments Established, Section 2-11, Police Department, subsection 2-11.7, Police Department Personnel, of the Revised General Ordinances of the Township of Chatham, is hereby amended as follows:

### § 2-11.7 Police Department Personnel.

The Police Department shall consist of a Chief of Police, up to two Lieutenants, up to five Sergeants, and up to 14 Patrol Officers. In addition, there may be clerical staff as shall be deemed necessary from time to time by the Township Committee.

- **Section 3**. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, division, clause or provisions so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.
- **Section 4**. All Ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.
  - **Section 5**. This Ordinance shall take effect according to law.

Mr. Shehady provided an overview of this ordinance. He stated that the table of organization for the CTPD will be updated to add an additional sergeant position to oversee the Detective Bureau and Special Operations. He also noted that the ordinance reflects that there are 14 patrolmen in the Department.

Committeeman Alperowitz moved to introduce Ordinance 2025-11. Committeewoman Ewald seconded the motion.

Mayor Choi noted that Chief Miller is always mindful of resources and the delivery of services. Committeeman Alperowitz said that the ordinance is well thought out regarding efficiency and budget considerations.

**WHEREAS**, the Mayor and Township Committee of the Township of Chatham (the "Township") adopted Resolution No. 2025-071 on February 25, 2025 authorizing the Township to publicly seek bids for an operator for the concession stand at Colony Pool located at 55 School Avenue, Chatham, New Jersey 07928 for the 2025 and 2026 pool seasons (the "Services"); and

**WHEREAS**, the Township received one bid on April 8, 2025 from Legacy Hospitality & Entertainment Group, LLC ("Legacy") for the Services in the amount of Six Thousand Dollars (\$6,000) as a one-time fee to be paid to the Township upon the execution of the contract for the Services; and

WHEREAS, the Township Attorney reviewed the bid received and recommends awarding the contract for the Services to Legacy as the only responsive and responsible bidder in the total amount of Six Thousand Dollars (\$6,000.00) (hereinafter collectively referred to as the "Contract Amount"); and

**WHEREAS**, the Township Chief Financial Officer has certified the availability of funds for the Contract Amount; and

**WHEREAS**, the Township desires to adopt this Resolution authorizing the award of the contract for the Services to Legacy.

**WHEREAS**, the Township received four (4) bids for the Sidewalk Project, all of which omitted the correct Federal Highway Administration forms, and therefore, all four (4) bidders were not qualified as a responsible bidder; and

**WHEREAS**, the Township Engineer recommended the rejection of the four (4) bids received for the Sidewalk Project; and

**WHEREAS**, on August 15, 2023, the Township Committee adopted Resolution No. 2023-169 rejecting the bids and authorizing a notice to re-bid for the Sidewalk Project; and

**WHEREAS**, the Township received one (1) bid on November 9, 2023 from Diamond Construction in the total amount of \$761,839.00 for the Sidewalk Project; and

**WHEREAS**, because the bid exceeded the estimate and only one bid was received, on April 23, 2024, the Township Committee adopted Resolution No. 2024-114 rejecting the bid and authorizing a notice to re-bid for the Sidewalk Project; and

**WHEREAS**, the Township received two (2) bids on June 27, 2024 from Diamond Construction in the total amount of \$623,914.00 and from Your Way Construction Inc. in the total amount of \$386,957.25 for the Sidewalk Project; and

**WHEREAS**, by the letter dated October 23, 2024, the Township Engineer recommended the rejection of the bids received from Diamond Construction and Your Way Construction Inc. as the documents submitted by the apparent low bidder were not adequate to satisfy the grant requirements and insufficient funds were available to award to the second bid received; and

**WHEREAS**, on November 12, 2024, the Township Committee adopted Resolution No. 2024-222 rejecting the bids and authorizing a notice to re-bid for the Sidewalk Project; and

WHEREAS, in response to the rebid, on January 9, 2025, the Township received six (6) bids from Your Way Construction Inc. in the total amount of \$399,723.25; DLS Contracting, Inc. in the total amount of \$584,908.50; AA Berms, LLC ("AA Berms") in the total amount of \$599,645.00; Diamond Construction in the total amount of \$732,004.00; Zuccaro, Inc. in the total amount of \$767,305.00; and Berto Construction, Inc. in the total amount of \$953,314.50; and

**WHEREAS**, Your Way Construction Inc. withdrew its bid in accordance with the requirements of the LPCL, and DLS Contracting, Inc.'s bid was rejected by the State of New Jersey because its bid did not comply with the disadvantaged business enterprise goals required; and

**WHEREAS**, the Township Engineer and Township Attorney recommend awarding the contract for the Sidewalk Project to AA Berms as the lowest responsive and responsible bidder in the total amount of Five Hundred Ninety-Nine Thousand Six Hundred and Forty-Five Dollars (\$599,645.00) (hereinafter collectively referred to as the "Contract Amount"); and

**WHEREAS**, the Township Chief Financial Officer has certified the availability of funds for the Contract Amount; and

**WHEREAS**, the Township desires to adopt this Resolution authorizing the award of the contract for the Sidewalk Project to AA Berms.

- 1. The recitals set forth above are incorporated by reference as if set forth at length herein.
