# MINUTES TOWNSHIP COMMITTEE WORKSHOP MEETING MARCH 21, 2023

Mayor Felice called the Regular Meeting of the Township Committee of the Township of Chatham to order at 7:31 P.M.

**Adequate Notice** of this meeting of the Township Committee was given as required by the Open Public Meetings Act as follows: Notice was given to both *The Chatham Courier* and the *Morris County Daily Record* on January 4, 2023; notice was posted on the bulletin board in the main hallway of the Municipal Building on January 4, 2023; and notice was filed with the Township Clerk on January 4, 2023.

#### **Roll Call**

Answering present to the roll call were Committeewoman Ewald, Committeeman Lois, Deputy Mayor Hamilton and Mayor Felice. Committeeman Choi arrived late.

Mayor Felice led the Flag Salute.

#### **Approval of Agenda**

The agenda was approved as written.

#### **Reports**

Committeeman Choi reported that guidelines were provided for negotiations with Chatham Borough for the Joint Recreation Agreement, and the negotiations are still under way.

Committeewoman Ewald reported that the Municipal Alliance has several upcoming programs. She further reported on behalf of the Historical Society that the Pathways of History Museum Tours on Saturday May 6 and Sunday May 7 will include the Red Brick Schoolhouse. The Senior Center's Shred Event will be on April 22<sup>nd</sup> at the Chatham Middle School. The Garden Tour will be on June 3<sup>rd</sup> and Fishawack will be on June 10<sup>th</sup>.

Committeeman Lois reported that memberships for Colony Pool are available and the Early Bird rates are available through March 31<sup>st</sup>. Summer jobs at Colony Pool are still available. Committeeman Lois noted ongoing negotiations for the Joint Recreation Program. He also stated that he and Committeeman Choi recently attended the Chatham Emergency Squad's officer installation dinner. Committeeman Lois commented on the number of calls that the Emergency Squad responded to in 2022, and applauded their effectiveness. Fundraising efforts will soon begin for a new command center.

Deputy Mayor Hamilton reported that the Friends of the Library Book Sale was recently held. Final numbers have not yet been released but the sale went well. Deputy Mayor Hamilton also gave an update on the Teen Center plans.

#### **Introduction of Ordinances**

Ordinance 2023-04

## **ORDINANCE 2023-04**

AN ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, AND STATE OF NEW JERSEY, AMENDING CHAPTER 30, LAND DEVELOPMENT, OF THE TOWNSHIP CODE, ARTICLE II, DEFINITIONS, § 30-6, DEFINITIONS.

**WHEREAS**, pursuant to *N.J.S.A.* 40:48-2, New Jersey municipalities may make, amend, and enforce ordinances they deem necessary and proper for the order and protection of persons and public health, safety and welfare of the municipality and its citizens; and

**WHEREAS**, after a review of the definition section, specifically impervious coverages, and based on the recommendation of the Municipal Engineer it has been determined to clarify such definitions.

**NOW, THEREFORE, BE IT ORDAINED,** by the Township Committee of the Township of Chatham, in the County of Morris, and State of New Jersey, that Chapter 30, Land Development, shall be amended as follows:

**SECTION 1**. Chapter 30, Land Development, Article II, Definitions, § 30-6, Definitions, is hereby amended as follows:

# IMPERVIOUS IMPROVEMENTS

Shall mean buildings, structures, pavement, <u>porous construction material</u>, or other improvements which prevent normal groundwater absorption.

# IMPERVIOUS SURFACES ON A SINGLE FAMILY RESIDENTIAL LOT IN RESIDENCE DISTRICTS

Shall mean buildings, roofed structures, pavement, driveways, parking and turnaround areas, sidewalks, patios, <u>porous construction material</u>, and other improvements which prevent normal ground water absorption, excluding decks and the surface area of swimming pools."

**SECTION 2.** If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining portions of this ordinance

**SECTION 3**. All ordinances of the Township of Chatham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4**. This ordinance shall take effect immediately upon passage and publication.

Committeewoman Ewald moved to introduce Ordinance 2023-04. Committeeman Lois seconded the motion.

Committeewoman Ewald asked about the content of the ordinance. Mr. King reported that it is based on the memo from Township Engineer John Ruschke, and the ordinance was reviewed by the Planning Board Attorney as well. He also said that there was an issue pertaining to the definition of impervious coverage, which is clarified by this ordinance.

Deputy Mayor Hamilton asked if there is a definition for porous construction material and if that needs to be defined. Mr. King said he would have to research that question to see if there is a legal definition.

Committeeman Lois addressed the enhancement of water absorption by porous materials. He also noted a typo in the ordinance.

# **ORDINANCE 2023-01**

ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless

authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Township Committee of the Township of Chatham in the County of Morris finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$122,928.55 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Chatham, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Township of Chatham shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$430,249.93, and that the CY 2023 municipal budget for the Township of Chatham be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mayor Felice opened the Public Hearing on Ordinance 2023-01. Seeing no public comment, Mayor Felice closed the Public Hearing.

Mayor Felice stated that the vote on this ordinance will be postponed until April.

<u>Ordinance 2023-02</u>

#### **ORDINANCE 2023-02**

AN ORDINANCE OF THE TOWNSHIP OF CHATHAM PROHIBITING THE TRESPASS UPON PRIVATE OR PUBLIC PROPERTY FOR THE PURPOSE OF TAMPERING WITH OR COMMITTING THE THEFT OR UNLAWFUL TAKING OF A MOTOR VEHICLE AND PRESCRIBING THE PENALTIES THEREFOR

**WHEREAS**, throughout the State of New Jersey,] communities have been victimized by car theft rings resulting in the damage and loss of private property and threatening the quality of life enjoyed by many; and

**WHEREAS**, in light of the state-wide increase in car thefts, programs to stem the theft of vehicles have been introduced in Chatham Township, including public information campaigns, adjustments in the tactics and methods of community policing, participation in regional law enforcement initiatives, installation of public situational awareness cameras and license plate readers and various strategies of information sharing; and

**WHEREAS**, the actions and efforts of the Chatham Township Police Department to meet this challenge are recognized, commended, and appreciated by the community; and

**WHEREAS**, the sum total of actions taken have resulted in a reduction in the number of cars stolen in our community; and

**WHEREAS,** further action is required to prevent criminals from pursuing car thefts in Chatham Township and to deter the organized criminal enterprise of bad actors regularly targeting our community; and

**WHEREAS**, the increase in key fob car access, the demand for luxury cars in other countries, and the change in state laws which lead to criminal "catch and release" remain unaddressed by state law makers and are encouraging lawless behavior in our community.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Chatham, that Section 3-7, of the Code of the Township of Chatham, be amended by the revision of Section 3-7.11, as follows:

## "§ 3-7.11 Intent to Steal.

No person shall hide or be in or near any public or private place with intent to steal any goods or chattels nor intentionally enter upon or trespass upon the land nor property of

any person without permission for the purpose of tampering with or committing the theft, or unlawful taking, of a motor vehicle.

Intent shall include entering or remaining on any driveway, paved surface, or location within 20 feet of a stationary motor vehicle, knowing that he or she is not licensed or privileged to enter or remain in said location, and committing any of the following acts:

Peering into a window or a motor vehicle that the person does not own or have license or privilege to possess; and

Pulling a door handle or taking an action in an attempt to open or unlock a motor vehicle that the person does not own or have license or privilege to possess; and/or

Possessing an electronic device, tool or machine that is capable of determining if an electronic key is located inside a motor vehicle or able to repeat, duplicate or capture the signal from an electronic key, or obtain illegal access to the vehicle."

**BE IT FURTHER ORDAINED,** that Section 3-7.12, of the Code of the Township of Chatham, shall be amended to read as follows:

#### "§3-7.12 Violations and Penalties.

Any person who violates any of the provisions of § 3-7 of this chapter shall upon conviction be liable to the penalty stated in Chapter 1, § 1-5. The continuation of such violation on each successive day shall constitute a separate offense. In addition to any other penalty prescribed by this section or Chapter 1, § 1-5, the minimum fine for a violation of § 3-7.11 shall be \$1,000 for the first offense and \$2,000 for each second or subsequent offense. Each property trespassed upon, or vehicle tampered or targeted for theft or unlawful removal, shall constitute a separate and distinct offense."

**BE IT FURTHER ORDAINED,** that this ordinance shall take effect following adoption and approval in a time and manner prescribed by law.

Mayor Felice opened the Public Hearing on Ordinance 2023-02. Seeing no public comment, Mayor Felice closed the Public Hearing.

Deputy Mayor Hamilton moved to adopt Ordinance 2023-02. Committeeman Lois seconded the motion.

Ordinance 2023-03

#### **ORDINANCE 2023-03**

AN ORDINANCE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, AND STATE OF NEW JERSEY, AMENDING CHAPTER 7, TRAFFIC, OF THE TOWNSHIP CODE, PART I, ON-STREET TRAFFIC REGULATIONS § 7-13, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS.

**WHEREAS,** pursuant to *N.J.S.A.* 40:48-2, New Jersey municipalities may make, amend, and enforce ordinances they deem necessary and proper for the order and protection of persons and public health, safety and welfare of the municipality and its citizens; and

**WHEREAS,** concerns have been raised regarding parking on Southern Boulevard in the Township of Chatham and the negative impact it has as it relates to emergency vehicles entering and exiting the municipal police department and public works buildings; and

**WHEREAS,** specifically, pursuant to *N.J.S.A.* 40:67-1, the Township of Chatham's governing body is authorized to amend and enforce ordinances to prevent and remove all encroachments, obstructions, and encumbrances in and/or upon all streets.

**NOW, THEREFORE, BE IT ORDAINED,** by the Township Committee of the Township of Chatham, in the County of Morris, and State of New Jersey, that Chapter 7 Traffic, shall be amended as follows:

**SECTION 1**. Part I., On-Street Traffic Regulations, § 7-13. Parking Prohibited At All Times On Certain Streets, be amended to include the following street and location:

"Name of Street	<u>Side</u>	Location
Southern Boulevard	Both	Beginning from the entrance and exit of the Police Station 1,000 feet South and 1,000 feet North"

**SECTION 2.** The Police Department is required to obtain approval from the County of Morris to regulate said parking inasmuch as Southern Boulevard is a County road, and the Township will place appropriate "No Parking" signage.

**SECTION 3**. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining portions of this ordinance.

**SECTION 4**. All ordinances of the Township of Chatham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 5**. This ordinance shall take effect immediately upon passage and publication.

Mayor Felice opened the Public Hearing on Ordinance 2023-03. Seeing no public comment, Mayor Felice closed the Public Hearing.
