#### MINUTES TOWNSHIP COMMITTEE REGULAR MEETING JULY 18, 2023

Mayor Felice called the Regular Meeting of the Township Committee of the Township of Chatham to order at 6:32 P.M.

**Adequate Notice** of this meeting of the Township Committee was given as required by the Open Public Meetings Act as follows: Notice was given to both *The Chatham Courier* and the *Morris County Daily Record* on July 14, 2023; notice was posted on the bulletin board in the main hallway of the Municipal Building on July 14, 2023; and notice was filed with the Township Clerk on July 14, 2023.

#### Roll Call

Answering present to the roll call were Committeewoman Ewald, Committeeman Lois and Mayor Felice. Deputy Mayor Hamilton arrived at the beginning of the Executive Session. Committeeman Choi was absent.

#### **Executive Session**

#### **RESOLUTION 2023-P-12**

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING CONFERENCE OF THE TOWNSHIP COMMITTEE WITH THE PUBLIC EXCLUDED

**WHEREAS**, N.J.S.A. 10:4-12 of the Open Public Meetings Act permits the exclusion of the public from a meeting in certain circumstances; and

**WHEREAS**, the Township Committee of the Township of Chatham is of the opinion that such circumstances presently exist.

**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

- 1. The public shall be excluded from discussion of the specified subject matter.
- 2. The general nature of the subject matter to be discussed is as follows:
  - a. Contract Negotiations Shared Services
  - b. Potential Acquisition of Property
  - c. Personnel
- 3. It is anticipated that the minutes on the subject matter of the Executive Session will be made public upon conclusion of the matter under discussion; and in any event, when appropriate pursuant to N.J.S.A. 10:4-7 and 4-13.
- 4. The Committee will come back into Regular Session and may take further action.
- 5. This Resolution shall take effect immediately.

Committeewoman Ewald moved to adopt Resolution 2023-P-12 to enter Executive Session at 6:34 PM. Committeeman Lois seconded the motion.

**Roll call**: Committeeman Choi, Absent; Committeewoman Ewald, Aye; Committeeman Lois, Aye; Deputy Mayor Hamilton, Absent; Mayor Felice, Aye.

The Township Committee returned to Public Session at 7:08 PM.

#### **Public Workshop Session**

#### Monthly Reports

Committeeman Lois asked about the movement of a sign on Township property by Public Works. Mr. Shehady stated that the sign at the top of the driveway for the Municipal Building was moved back because it was blocking the site line for oncoming traffic. Committeeman Lois asked about the ranking of roads for repaving. Mr. Shehady said that the Township Engineer and the Public Works Director coordinated to review the roads.

Mayor Felice asked for background on the Purchasing Ordinance. Mr. Shehady explained that the Township's current ordinance is outdated, and dates to a time before the Qualified Purchasing Agent (QPA) position was created. As there is not currently a provision for a QPA, this ordinance formally creates that position for the Township. Mr. Shehady also said that he will periodically review the Township's code book to see if there are any ordinances that are out of date.

Mr. Shehady commented on a resolution on the Consent Agenda to join a co-op. He stated that joining the co-op will allow the Township to purchase equipment that the Chatham Township Fire Department has requested.

#### **Hearing of Citizens**

Mayor Felice opened the Hearing of Citizens. Seeing none, Mayor Felice closed the Hearing of Citizens.

The Township Committee took a recess at 7:15 PM.

#### **Regular Public Session**

The Regular Public Session began at 7:30 PM.

Mayor Felice led the Flag Salute.

#### **Mayor's Statement**

Mayor Felice stated that as part of the Township Committee's ongoing commitment to enhance the roads in the Township, several streets will be resurfaced this summer. The roads to be resurfaced are School Avenue, Thornley Avenue, Maple Street, Floral Street, and Spring Street. Efforts will be made to minimize any inconvenience to residents during the repaving work.

#### Approval of Agenda

Committeeman Lois asked that Resolutions 2023-156 be pulled from the Consent Agenda for separate discussion and a vote.

Committeewoman Ewald moved to approve the agenda as amended. Deputy Mayor Hamilton seconded the motion which carried unanimously.

#### **Hearing of Citizens**

Mayor Felice asked if any written comments had been submitted in a timely manner.

The Clerk stated that the following written comments were received:

1. Phil Ankel, Jay Road, wrote the following:

"In regards to the upcoming vote on the budget, I wanted to raise just a few comments.

- a. I am a strong supporter of spending to keep up our recreational facilities. As a general rule, I object to the use of Open Space funds for routine Township recreational facilities expenditures.
- b. I notice that one Committee Member has been writing public letters to the editor and requesting that people sign on to their google poll in support of certain proposed expenditures. They are also asking for personal information of those google poll participants. Is this Member acting on behalf of the Committee? If not, why are Chatham Township logos listed as part of the solicitation? I think the current Committee leadership needs to make clear what are official actions that are taken on behalf of the Township and which actions are not. I find it unseemly that a representative of one political party is soliciting Township residents to provide them

- with their personal details in order for those residents to be heard on topics of public concern.
- c. Certain candidates for Township Committee (who are now Committee members) have campaigned now for several years on a platform in opposition to so-called runaway spending and taxes. Yet as I look at my tax bill, it is essentially the same as the bill I had when those candidates were running. And I see at least one of those candidates soliciting even further increases in spending. I fail to see where this current Committee majority has actually substantially cut any spending or my taxes. Which suggests to me they agreed with the spending and taxes all along.
- d. I urge greater comity on this Township Committee than was shown at the last Committee Meeting. And greater clarity on who represents the Committee and in what capacity."

Committeeman Lois responded by stating that interest costs and legal fees have been reduced, and those monies have been redirected to other areas.

Mayor Felice stated that she will address some of Mr. Ankel's concerns later in the meeting.

Mayor Felice opened the Hearing of Citizens.

1. Maureen Kelly, Mountain Avenue, expressed her support for the Capital Budget as it presently exists and said that recreation should be generally funded through the operating budget. She also advocated against using open space funds as a petty cash fund. Mrs. Kelly also commented on school taxes, and stated that the Township contributes 55% of the tax revenue received by the School District of the Chathams. Mrs. Kelly said that the Borough recently did a revaluation, and asked if the ratio contributed by each municipality could change.

Committeewoman Ewald said that she also wants to follow up on the equalized valuation and how that will affect the Township's portion of taxes for the School District.

Seeing no further public comment, Mayor Felice closed the Hearing of Citizens

#### Reports

Committeeman Lois reported about the recent major power failure that affected both the Township and the Borough. He stated that the problem arose from an overheating problem at the Traynor Substation. Committeeman Lois commented on the number of circuits that JCP&L has in the Township. He also stated that an official report on a reliability study should be forthcoming. Committeeman Lois further reported that Colony Pool has their final home swim meet tonight. He also reported that there will be an All Chatham Cup swimming competition held by Fairmount Country Club, which will also include Colony Pool, Minisink, and Chatham Fish & Game.

Regarding the power outage, Committeewoman Ewald noted that there were secondary impacts. She also said that it would benefit residents to submit any complaints to both JCP&L and the Board of Public Utilities. She also invited residents to email their complaints to her so she can pass them on. Committeeman Lois stated that a representative from JCP&L has offered to address the Township Committee during a meeting. He also commented on the power load being higher with people working from home, running air conditioning and charging electric cars.

Deputy Mayor Hamilton reported that construction of the Teen Center at the Library of the Chathams is underway. He also reported that recently there was a violent crime incident in the Township. He noted the efforts of Officer Cortez and Sergeant Gallo who responded to the scene of the incident and provided life saving first aid to the victim and apprehended the suspect.

Ordinance 2023-07

#### **ORDINANCE 2023-07**

CAPITAL ORDINANCE OF THE TOWNSHIP OF CHATHAM, IN THE COUNTY OF MORRIS, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE TOWNSHIP, APPROPRIATING THEREFOR THE SUM OF \$805,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP.

**BE IT ORDAINED** by the Township Committee of the Township of Chatham, in the County of Morris, New Jersey, as follows:

Section 1. The Township of Chatham, in the County of Morris, New Jersey (the "Township") is hereby authorized to make various public improvements and acquisitions in, by and for the Township, including, but not limited to:

#### (A) Police Department

Acquisition of new automotive vehicles, including original apparatus and equipment, consisting of SUVs

Estimated Cost: \$120,000

#### (B) Roads and Sidewalks

Undertaking of improvements to various roads and construction of sidewalks, as set forth on a list prepared or to be prepared by the Township Engineer and placed on file with the Township Clerk and hereby approved as if set forth herein in full. Depending upon the contract price and other exigent circumstances, and upon approval by the Township Committee, there may be additions to or deletions from the aforesaid list.

Estimated Cost: \$500,000

#### (C) <u>Building Improvements</u>

Installation of new shingle roof on Department of Public Works Storage 1. Estimated Cost: \$118,000

#### (D) <u>Volunteer Fire Departments</u>

Acquisition of new additional or replacement equipment and machinery consisting of self-contained breathing apparatus equipment, turnout gear and various items of firefighting, emergency and safety equipment.

Estimated Cost: \$67,000

Section 2. The sum of \$805,000 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Capital Improvement Fund of the Township, as hereinafter provided. The sum of \$805,000 is hereby appropriated from the Capital Improvement Fund of the Township to the payment of the cost of said purposes.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall include all work, materials and appurtenances necessary and suitable therefor. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.

Mayor Felice opened the Public Hearing on Ordinance 2023-07. Seeing no public comment, Mayor Felice closed the Public Hearing.

Committeewoman Ewald moved to adopt Ordinance 2023-07. Deputy Mayor Hamilton seconded the motion.

Committeeman Lois opined that capital funds for recreation should be included in the ordinance.

Deputy Mayor Hamilton said that the 2023 Budget supports recreation and he is in favor of the Capital Ordinance as written.

Committeewoman Ewald also noted that the Township Committee supports recreation, and she is not favor of setting aside funds without knowing what they would be used for.

Mayor Felice addressed recent misinformation that has recently been spread within the community regarding the use of capital funds for recreation. She highlighted the capital funds that are presently allocated to recreation purposes. Mayor Felice also described the process by which projects are prioritized. She further addressed the use of the Township seal on documents that are not officially authorized, and commented that Township Committee members should not act unilaterally or spread deception.

#### **ORDINANCE 2023-08**

CAPITAL ORDINANCE OF THE TOWNSHIP OF CHATHAM, IN THE COUNTY OF MORRIS, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE SEWER UTILITY OF THE TOWNSHIP, APPROPRIATING THEREFOR THE SUM OF \$576,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE SEWER UTILITY CAPITAL IMPROVEMENT FUND AND SEWER UTILITY CAPITAL FUND BALANCE OF THE TOWNSHIP.

**BE IT ORDAINED** by the Township Committee of the Township of Chatham, in the County of Morris, New Jersey, as follows:

Section 1. The Township of Chatham, in the County of Morris, New Jersey (the "Township") is hereby authorized to make various improvements and acquisitions in, by and for the Sewer Utility of the Township, including, but not limited to: (i) replace comminution equipment; (ii) repair sludge piping at WPC Plant; (iii) replace transfer switch at WPCP and SSPS; (iv) replace fire hydrant and re-route piping; (v) rebuild vertical turbine pump 3 and compressor 3; (vi) modify caustic above ground tanks/piping; (vii) install new VFDs at Southside Pump Station; and (viii) preliminary engineering for WPC Plant upgrade. Said improvements and acquisitions shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$576,000 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Sewer Utility Capital Improvement Fund and Sewer Utility Capital Fund Balance of the Township. The sum of \$336,000 is hereby appropriated from the Sewer Utility Capital Improvement Fund of the Township to the payment of the cost of said purpose. The sum of \$240,000 is hereby appropriated from the Sewer Utility Capital Fund Balance of the Township to the payment of the cost of said purpose.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.

Mayor Felice opened the Public Hearing on Ordinance 2023-08. Seeing no public comment, Mayor Felice closed the Public Hearing.

Committeewoman Ewald moved to adopt Ordinance 2023-08. Deputy Mayor Hamilton seconded the motion.

#### **ORDINANCE 2023-09**

# ORDINANCE OF THE TOWNSHIP OF CHATHAM AMENDING CHAPTER 2 ADMINISTRATION, ARTICLE II MUNICIPAL OFFICIALS AND EMPLOYEES § 2-2.6, § 2-2.7 and § 2-7 CREATING THE POSITION OF PURCHASING AGENT FOR THE TOWNSHIP OF CHATHAM

WHEREAS, pursuant to *N.J.S.A.* 40:48-1, New Jersey municipalities may make, amend, and enforce ordinances they deem necessary and proper for the order of the municipality and its citizens as it relates to officers and employees, and prescribe in accordance with the law their duties and terms and provide for the employment of such employees as may be deemed necessary for the efficient conduct of the affairs of the municipality; and

**WHEREAS,** *N.J.S.A.* 40A:11-9 permits a municipality to designate a Qualified Purchasing Agent, (herein "QPA") and *N.J.A.C.* 5:34, *et seq.*, establishes the criteria for qualifying as a QPA; and

WHEREAS, a review has been made of Chapter 2, Administration, Article II, Municipal Officials and Employees, indicating that that section of the code was enacted in 1975 with the last amendment being 1989, or thirty four (34) years ago; and

**WHEREAS**, based upon *N.J.S.A.* 40A:11-9, effective August 10, 2015, and as recommended by the Township Administrator, the following amendments, deletions, and additions have been determined to be in the best interest of the municipality and its citizens and deemed necessary for the efficient conduct of the affairs of the municipality.

**NOW, THEREFORE, BE IT ORDAINED,** by the Township Committee of the Township of Chatham, in the County of Morris, and State of New Jersey, that Chapter 2, Administration, Article II, Municipal Officials and Employees, shall be amended as follows:

#### SECTION 1. § 2-2.6 Duties and Responsibilities, be amended to include the following section:

"1. In conjunction with the Township's Chief Financial Officer and Purchasing Agent, the Township Administrator shall review and oversee the purchasing practices and policies of all departments for the purpose of ensuring that purchases are made in accordance with applicable law, the Township Code and sound purchasing practices."

**SECTION 2. § 2-2.7 Responsibility for Purchasing and Contracting,** be deleted in its entirety, and reserved.

**SECTION 3. § 2-7 (RESERVED)**, be amended to include the following section:

"§ 2-7 Qualified Purchasing Agent

§ 2-7.1 Creation.

There is hereby created the part-time position of Qualified Purchasing Agent who shall serve no specific term and shall be appointed by the Township Committee of the Township of Chatham.

§ 2-7.2 Compensation.

Compensation for the position of Qualified Purchasing Agent shall be set annually within the Chatham Township Salary Ordinance.

§ 2-7.3 Schedule; duties and responsibilities.

The Qualified Purchasing Agent is required to possess a valid Qualified Purchasing Agent certificate, as issued by the New Jersey Division of Local Government Services, Department of Community Affairs, and perform all duties imposed by law, administrative code, or regulation including but not limited to the following:

- a. An individual shall be considered a Qualified Purchasing Agent pursuant to *N.J.S.A.* 40A:11-9b to exercise the supplemental authority as set forth in *N.J.S.A.* 40A:11-3 and 40A:11-4.3 upon meeting the criteria relevant to the individual as set forth in *N.J.S.A.* 40A:11-9.
- b. To meet the criteria of required training courses set forth in *N.J.S.A.* 40A:11-9b (5), an applicant shall successfully complete the following courses provided by the Center for Government Services at Rutgers, the State University, by the Division of Local Government

Services, or, with the approval of the director, an alternative state university or county college:

- 1. Principles of Public Purchasing I;
- 2. Principles of Public Purchasing II;
- Principles of Public Purchasing III;
  Municipal Finance Administration, or either of the following courses: Municipal Finance Administration for Municipal Clerks or Municipal Finance Administration for Purchasing Agents
- c. There shall be no specific hours of work for the position of Qualified Purchasing Agent; however, said position shall require the coordination and certification of all purchases by the Township within the confines of the Local Public Contracts Law; and abide by the bid thresholds as contained therein.
- d. Prepare, as needed, reports; establish and maintain files.
- e. Maintain renewal of state issued certification.
- f. The Qualified Purchasing Agent shall have, on behalf of the Township Committee of the Township of Chatham, the authority, responsibility, and accountability for the purchasing activity pursuant to Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.): to prepare public advertising for and to receive bids and requests for proposals for the provision or performance of goods, services, and construction contracts; to award contracts pursuant to New Jersey law in accordance with the regulations, forms, and procedures promulgated by state regulatory agencies, and conduct any activities as may be necessary or appropriate to the purchasing function of the Township of Chatham.
- g. The Qualified Purchasing Agent may award a contract without bid if the aggregate amount does not exceed in a contract year the total sum of the bid threshold amount adjusted and set by the Governor pursuant to N.J.S.A. 40A:11-3(c) as referenced by Local Finance Notices.
- h. Perform all other duties as may be required by the Township Committee of the Township of Chatham or Chatham Township Administrator."

**SECTION 3**. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. All ordinances of the Township of Chatham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4**. This ordinance shall take effect immediately upon passage and publication.

Committeewoman Ewald moved to introduce Ordinance 2023-09. Deputy Mayor Hamilton seconded the motion.

Committeeman Lois said it is his understanding that this ordinance cleans up the Township code book and does not necessarily authorize the hiring of a new staff member. Mr. Shehady said that the Township has had a QPA for several years. Mr. King noted that this ordinance formally creates the position of QPA which is already staffed. The appropriation of funds for salary and wages for the position was discussed, and Mr. Shehady said that compensation has been rolled into the salary of the staff member who is serving as QPA.

Committeeman Lois asked that the ordinance be tabled so that he can better understand it. Mr. Shehady reiterated that the purpose of the ordinance is to clarify the Township code book.

Committeewoman Ewald noted that the Township Committee will retain authority to approve salaries, and she said she supports moving forward with the ordinance at this meeting.

1. The Township Committee does hereby authorize submission of an application for DMHAS Grant funding for the Municipal Alliance Committee of the Chathams for Year One Grant Term 9/1/23 – 9/30/25 in the amount of:
