MINUTES TOWNSHIP COMMITTEE REGULAR MEETING AUGUST 15, 2023

Mayor Felice called the Regular Meeting of the Township Committee of the Township of Chatham to order at 6:30 P.M.

Adequate Notice of this meeting of the Township Committee was given as required by the Open Public Meetings Act as follows: Notice was given to both *The Chatham Courier* and the *Morris County Daily Record* on August 11, 2023; notice was posted on the bulletin board in the main hallway of the Municipal Building on August 11, 2023; and notice was filed with the Township Clerk on August 11, 2023.

Roll Call

Answering present to the roll call were Committeeman Choi, Committeewoman Ewald, Committeeman Lois and Mayor Felice. Deputy Mayor Hamilton arrived at the beginning of the Executive Session.

Committeeman Choi, Committeewoman Ewald and Deputy Mayor Hamilton participated via Zoom.

Executive Session

RESOLUTION 2023-P-13

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING CONFERENCE OF THE TOWNSHIP COMMITTEE WITH THE PUBLIC EXCLUDED

WHEREAS, N.J.S.A. 10:4-12 of the Open Public Meetings Act permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, the Township Committee of the Township of Chatham is of the opinion that such circumstances presently exist.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, as follows:

- 1. The public shall be excluded from discussion of the specified subject matter.
- 2. The general nature of the subject matter to be discussed is as follows:

- 4. The Committee will come back into Regular Session and may take further action.
- 5. This Resolution shall take effect immediately.

Committeeman Lois moved to adopt Resolution 2023-P-13 to enter Executive Session at 6:34 PM. Committeeman Choi seconded the motion.

The Township Committee returned to Public Session at 7:09 PM.

Public Workshop Session

Monthly Reports

Committeeman Lois asked about a fee waiver cited in the Construction Official's report. Committeewoman Ewald said that it was for the affordable housing construction at 522 Southern Boulevard and was part of a previous agreement. Mr. Shehady said that the developer's agreement calls for a waiver of the permit fees for that project. He also noted that revenues are lower than last year's because 2022's revenue included permit fees for The Enclave.

Committeeman Lois asked about metrics for the Colony Tennis pickleball program. Mr. Shehady said that there has been positive feedback, and having striping at the Colony Tennis Courts negates the need for pickleball courts at Nash Field. Committeeman Lois asked how that decision was made. Committeeman Choi commented on site selection discussions.

Local Aid Infrastructure Fund Project

Engineer Ruschke gave a presentation about a grant received from the NJDOT's Local Aid Infrastructure Fund. The project will be for Pedestrian Safety and ADA Improvements. Mr. Ruschke provided an anticipated timeline for the project. He also cited each location where crosswalks and ADA ramps will be improved, all of which are along Fairmount Avenue.

Mr. Shehady said that notice will be provided to residents so they will be aware of the project. There will also be website and social media posts about the project.

Mr. Ruschke noted that vegetation will be cut back as appropriate so that there will be visibility for the crosswalks.

Mr. Choi asked about street lighting. Mr. Ruschke said that it may be needed by Nicholson Drive.

Mr. Choi noted an issue with Amazon trucks getting into accidents.

Regular Public Session

The Regular Public Session began at 7:32 PM.

Ordinance 2023-09

ORDINANCE 2023-09

ORDINANCE OF THE TOWNSHIP OF CHATHAM AMENDING CHAPTER 2 ADMINISTRATION, ARTICLE II MUNICIPAL OFFICIALS AND EMPLOYEES § 2-2.6, § 2-2.7 and § 2-7 CREATING THE POSITION OF PURCHASING AGENT FOR THE TOWNSHIP OF CHATHAM

WHEREAS, pursuant to *N.J.S.A.* 40:48-1, New Jersey municipalities may make, amend, and enforce ordinances they deem necessary and proper for the order of the municipality and its citizens as it relates to officers and employees, and prescribe in accordance with the law their duties and terms and provide for the employment of such employees as may be deemed necessary for the efficient conduct of the affairs of the municipality; and

WHEREAS, N.J.S.A. 40A:11-9 permits a municipality to designate a Qualified Purchasing Agent, (herein "QPA") and N.J.A.C. 5:34, et seq., establishes the criteria for qualifying as a QPA; and WHEREAS, a review has been made of Chapter 2, Administration, Article II, Municipal Officials and Employees, indicating that that section of the code was enacted in 1975 with the last amendment being 1989, or thirty four (34) years ago; and

WHEREAS, based upon *N.J.S.A.* 40A:11-9, effective August 10, 2015, and as recommended by the Township Administrator, the following amendments, deletions, and additions have been determined to be in the best interest of the municipality and its citizens and deemed necessary for the efficient conduct of the affairs of the municipality.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Chatham, in the County of Morris, and State of New Jersey, that Chapter 2, Administration, Article II, Municipal Officials and Employees, shall be amended as follows:

SECTION 1. § 2-2.6 Duties and Responsibilities, be amended to include the following section:

"1. In conjunction with the Township's Chief Financial Officer and Purchasing Agent, the Township Administrator shall review and oversee the purchasing practices and policies of all departments for the purpose of ensuring that purchases are made in accordance with applicable law, the Township Code and sound purchasing practices."

SECTION 2. § 2-2.7 Responsibility for Purchasing and Contracting, be deleted in its entirety, and reserved.

SECTION 3. § 2-7 (RESERVED), be amended to include the following section:

"§ 2-7 Qualified Purchasing Agent

§ 2-7.1 Creation.

There is hereby created the part-time position of Qualified Purchasing Agent who shall serve no specific term and shall be appointed by the Township Committee of the Township of Chatham.

§ 2-7.2 Compensation.

Compensation for the position of Qualified Purchasing Agent shall be set annually within the Chatham Township Salary Ordinance.

§ 2-7.3 Schedule; duties and responsibilities.

The Qualified Purchasing Agent is required to possess a valid Qualified Purchasing Agent certificate, as issued by the New Jersey Division of Local Government Services, Department of Community Affairs, and perform all duties imposed by law, administrative code, or regulation including but not limited to the following:

- a. An individual shall be considered a Qualified Purchasing Agent pursuant to *N.J.S.A.* 40A:11-9b to exercise the supplemental authority as set forth in *N.J.S.A.* 40A:11-3 and 40A:11-4.3 upon meeting the criteria relevant to the individual as set forth in *N.J.S.A.* 40A:11-9.
- b. To meet the criteria of required training courses set forth in *N.J.S.A.* 40A:11-9b (5), an applicant shall successfully complete the following courses provided by the Center for Government Services at Rutgers, the State University, by the Division of Local Government Services, or, with the approval of the director, an alternative state university or county college:
 - 1. Principles of Public Purchasing I;
 - 2. Principles of Public Purchasing II;
 - 3. Principles of Public Purchasing III;
 - 4. Municipal Finance Administration, or either of the following courses: Municipal Finance Administration for Municipal Clerks or Municipal Finance Administration for Purchasing Agents
- c. There shall be no specific hours of work for the position of Qualified Purchasing Agent; however, said position shall require the coordination and certification of all purchases by the Township within the confines of the Local Public Contracts Law; and abide by the bid thresholds as contained therein.
- d. Prepare, as needed, reports; establish and maintain files.
- e. Maintain renewal of state issued certification.
- f. The Qualified Purchasing Agent shall have, on behalf of the Township Committee of the Township of Chatham, the authority, responsibility, and accountability for the purchasing activity pursuant to Local Public Contracts Law (*N.J.S.A.* 40A:11-1, *et seq.*): to prepare public advertising for and to receive bids and requests for proposals for the provision or performance of goods, services, and construction contracts; to award contracts pursuant to New Jersey law in accordance with the regulations, forms, and procedures promulgated by state regulatory agencies, and conduct any activities as may be necessary or appropriate to the purchasing function of the Township of Chatham.
- g. The Qualified Purchasing Agent may award a contract without bid if the aggregate amount does not exceed in a contract year the total sum of the bid threshold amount adjusted and set by the Governor pursuant to *N.J.S.A.* 40A:11-3(c) as referenced by Local Finance Notices.
- h. Perform all other duties as may be required by the Township Committee of the Township of Chatham or Chatham Township Administrator."

SECTION 3. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. All ordinances of the Township of Chatham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This ordinance shall take effect immediately upon passage and publication.

Mayor Felice opened the Public Hearing on Ordinance 2023-09. Seeing no public comment, Mayor Felice closed the public hearing.

Committeewoman Ewald moved to adopt Ordinance 2023-09. Committeeman Choi seconded the motion.

Committeeman Lois asked if this ordinance mandates a salary increase. He further asked if the QPA is a credential required of the Township Administrator. Mr. King said that the Code Book previously designated the Township Administrator as the purchasing agent, and that designation was made long before the QPA certification was available. Mr. King also noted that any salary increases would be by resolution of the Township Committee. The Township Committee also has the ability to adjust the bid threshold within statutory limits.

Committeeman Lois asked if there is a stipend that will be paid as a result of the adoption of this ordinance. Mr. Shehady stated that the ordinance does not include a stipend for the QPA. He also said that the ordinance is to ensure that the Township's Code Book conforms with State law.

- 1. The Township Committee hereby rejects all bids as no bidders were qualified as a result of their failure to submit the appropriate Federal Highway Administration (FHWA) forms.
- 2. The Township Committee hereby gives authorization to the QPA, the Township Administrator and the Township Engineer to prepare the necessary bid documents for the

Lafayette Avenue Sidewalk Project and advertise the same upon approval of the documents by the DOT.

WHEREAS, the North Jersey Wastewater Cooperative through the Passaic Valley Sewerage Commission has awarded a contract to Pumping Services, Inc., 201 Lincoln Boulevard, Middlesex, NJ 08846, for the acquisition of various equipment and spare parts under Contract No. B270-2 as indicated on the attached November 17, 2022 service quotation in the amount of \$43,853.30; and

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM AUTHORIZING CHANGE ORDER NO. 1 FOR A CONTRACT FOR COLONY TENNIS IMPROVEMENTS WITH STRAIGHT EDGE STRIPING

WHEREAS, Resolution No. 2023-148, approved on June 27, 2023, awarded a contract to Straight Edge Striping for Colony Tennis Improvements Project for a total contract amount of \$161,820.00; and
