RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF  
CHATHAM APPROVING FIREWORKS FOR FAIRMOUNT COUNTRY CLUB**

**WHEREAS**, state regulations require municipal governing body approval for the use of fireworks displays; and

**WHEREAS**, the Township has received an application to conduct a fireworks display by the Fairmount Country Club on September 4, 2023, to take place at the Fairmount Country Club on Southern Boulevard, Chatham, New Jersey; and
