RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICE CONTRACT TO LARACY ASSOCIATES LLC FOR TAX COLLECTOR SERVICES 2024-2025

WHEREAS, the Township of Chatham (the "Township"), pursuant to the Local Public Contracts Law, specifically N.J.S.A. 40A:11-5(1)(a)(i) (the "LPCL"), is authorized to enter into contracts for professional services without public advertising for bids and bidding therefor; and

WHEREAS, in accordance with the LPCL, the Township desires to hire an outside consultant to provide the Township with Certified Tax Collector services commencing on November 1, 2024 for an initial term of three (3) months, and renewable up to a total term of one (1) year at the option of the Township Administrator (the "Services"); and

WHEREAS, the Township received a proposal dated September 26, 2024 from Laracy Associates, LLC ("Laracy") to provide the Services to the Township for an estimated total amount of Two Thousand Two Hundred Fifty Dollars (\$2,250.00) per month (the "Proposal"); and

WHEREAS, the Township desires to award a contract to Laracy to provide the Services to the Township in accordance with the Proposal.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Chatham that authorization is given as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The Township Committee hereby authorizes a contract with Laracy to provide the Services to the Township in accordance with the terms set forth in the Proposal, commencing on November 1, 2024 for an initial term of three (3) months, and renewable up to a total term of one (1) year at the option of the Township Administrator for an amount not to exceed Twenty-Seven Thousand Dollars (\$27,000.00).
- 3. Within ten days of the adoption of this Resolution, notice of the nature, duration and amount of the contract shall be published once in the newspaper of general circulation and a copy of this Resolution and the agreements shall be on file and available in the offices of the Township.

4. This Resolution shall take effect immediately.
