RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM AUTHORIZING THE PURCHASE OF GASOLINE AND DIESEL FROM GRIFFITH-ALLIED TRUCKING, LLC PURSUANT TO STATE CONTRACT MASTER BLANKET PURCHASE ORDERS 19-FLEET-00978 AND 19-FOOD-01097

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a cooperative pricing system and to enter into cooperative pricing agreements with other contracting units as defined under N.J.S.A. 40A:11-2(1) for its procurement of goods and services; and

WHEREAS, the Township may, without advertising for bids, purchase any materials, supplies, services, or equipment under an approved State Contract; and

WHEREAS, the Township needs to purchase gasoline as listed on the State Contract Master Blanket Purchase Order 19-Fleet-00978 (the “**Contract**”); and.

WHEREAS, the Township needs to purchase diesel fuel as listed on the State Contract Master Blanket Purchase Order 19-FOOD-01097 (the “**Contract**”); and.

WHEREAS, the State Contract awarded a contract to Griffith-Allied Trucking, LLC, for the purchase of gasoline under Contract for a period from November 1, 2019 through October 31, 2024; and

WHEREAS, the State Contract awarded a contract to Griffith-Allied Trucking, LLC, for the purchase of diesel fuel under Contract for a period from April 1, 2020 through March 31, 2025; and

WHEREAS, the Chief Financial Officer of the Township has certified that adequate funds for such a purchase are available.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Chatham, County of Morris, State of New Jersey, that:

1. The forgoing Recitals are hereby incorporated herein by reference as if set forth at length.
2. The Township hereby authorizes the purchase of gasoline from Griffith-Allied Trucking, LLC for a period commencing on January 1, 2024 and terminating on December 31, 2024, pursuant to Master Blanket Purchase Order 19-Fleet-00978.
3. The Township hereby authorizes the purchase of diesel fuel from Griffith-Allied Trucking, LLC for a period commencing on January 1, 2024 and terminating on December 31, 2024, pursuant to Master Blanket Purchase Order Master Blanket Purchase Order 19-FOOD-01097.

4. A certified copy of this Resolution shall be provided by the Township Clerk to each of the following:

 - ii. Township Chief Financial Officer
 - iii. Township Director of Public Works
 - iv. Griffith-Allied Trucking, LLC
5. This Resolution shall take effect immediately.


