RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, ACCEPTING THE BID AND AWARDING THE CONTRACT FOR ROAD AND DRAINAGE IMPROVEMENTS OF HILLSIDE AVENUE TO P.M. CONSTRUCTION CORP. IN THE TOTAL AMOUNT OF \$314,790 IN ACCORDANCE WITH THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, the Mayor and Township Committee of the Township of Chatham (the “Township”) adopted Resolution No. 2025-111 on April 22, 2025 authorizing the Township to publicly seek bids for an operator for road and drainage improvement of Hillside Avenue in the Township of Chatham (the “Services”); and

WHEREAS, the Township received one bid on July 2, 2025 from P.M. Construction Corp., located at 1310 Central Avenue, Hillside, New Jersey (“PM”), for the Services in the amount of Three Hundred Fourteen Thousand Seven Hundred Ninety Dollars and 00/100 Cents (\$314,790.00); and

WHEREAS, the Township Engineer and Township Attorney recommend award of the contract for the Services to PM as the only responsive and responsible bidder in the total amount of Three Hundred Fourteen Thousand Seven Hundred Ninety Dollars and 00/100 Cents (\$314,790.00) (the “Contract Amount”); and

WHEREAS, the Township Chief Financial Officer has certified the availability of funds for the Contract Amount; and

WHEREAS, in 2025 the Township received a grant from NJDOT Municipal Aid Project in the amount of \$261,720 (the “Grant”) to utilize in connection with the Services; and

WHEREAS, the Township desires to adopt this Resolution authorizing the award of the contract for the Services to PM.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Chatham, County of Morris, and State of New Jersey, as follows:

1. The foregoing recitals are hereby incorporated herein by reference as if set forth at length.
2. The contract for the Services is hereby awarded to PM located in Hillside, New Jersey, in the amount of Three Hundred Fourteen Thousand Seven Hundred Ninety Dollars and 00/100 Cents (\$314,790.00). The Mayor, Township Administrator, Township Clerk and all other necessary Township personnel, are hereby directed and authorized to enter into a contract with PM for the Services, and to in all other ways carry out and effectuate the purposes thereof.

3. This Resolution shall be effective immediately.
