

RESOLUTION 2026-139

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, ACCEPTING THE BID AND AWARDING THE CONTRACT FOR THE RIVER ROAD PAVING PROJECT TO DLS CONTRACTING, INC. IN THE TOTAL AMOUNT OF \$462,767.50 IN ACCORDANCE WITH THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, on May 26, 2026, the Township Committee of the Township of Chatham (the “Township”) adopted Resolution No. 2026-110 authorizing the Township to publicly seek bids for an operator for the milling and resurfacing of River Road from Fairmount Avenue to Passaic Street in the Township of Chatham (the “Services”); and

WHEREAS, the Township received seven (7) bids on July 7, 2026 for the Services from: (1) DLS Contracting, Inc., located in Pine Brook, New Jersey (“DLS”), for the Services in the amount of \$462,767.50; (2) AJM Contractors, Inc., located in Clifton, New Jersey in the amount of \$463,422.00; (3) Top Line Construction Corp., located in Somerville, New Jersey in the total amount of \$474,722.36; (4) CCM Contracting, Inc., located in Green Brook, New Jersey in the total amount of \$475,833.50; (5) Crossroads Paving, located in Newark, New Jersey in the total amount of \$506,787.50; (6) D&L Paving Contractor Inc., located in Nutley, New Jersey in the total amount of \$507,379.20; and (7) Reivax Contracting Corp. located in Flemington, New Jersey in the total amount of \$540,842.50; and

WHEREAS, the Township Engineer and Township Attorney recommend award of the contract for the Services to DLS as the lowest responsive and responsible bidder in the total amount of Four Hundred Sixty-Two Thousand Seven Hundred Sixty-Seven Dollars and Fifty Cents (\$462,767.50) (the “Contract Amount”); and

WHEREAS, the Township received a grant from the New Jersey Department of Transportation (the “NJDOT”) Municipal Aid Project in the amount of \$252,707.00 to utilize in connection with the Services; and

WHEREAS, the Township desires to adopt this Resolution authorizing the award of the contract for the Services to DLS, subject to review and approval by the NJDOT.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Chatham, County of Morris, and State of New Jersey, as follows:

1. The foregoing recitals are hereby incorporated herein by reference as if set forth at length.
2. The contract for the Services is hereby awarded to DLS in the amount of Four Hundred Sixty-Two Thousand Seven Hundred Sixty-Seven Dollars and Fifty Cents (\$462,767.50).

The Mayor, Township Administrator, Township Clerk and all other necessary Township personnel, are hereby directed and authorized to enter into a contract with DLS for the Services, and to in all other ways carry out and effectuate the purposes thereof.

3. This Resolution shall be effective immediately.
